At present, we are facing a difficult time due to COVID19 Pandemic and most of our activities are affected. MHA in its order dated 15<sup>th</sup> April 2020 stated that all health services are deemed essential and need to be functional across the country and Prevention & Control of VBDs including Dengue is one of the essential health services. As you are aware that every year 16<sup>th</sup> May is observed as 'National Dengue Day' (NDD) across the country which provides an opportunity to emphasize on transmission prevention, create community awareness and sensitize the stakeholders/partners. This year the NDD is amidst the COVID-19 crisis and many of our activities like advocacy meetings, rallies, meetings or gatherings are not admissible due to prevailing situation. The theme of NDD 2020 is "*Effective Community Engagement: Key to Dengue Control*". Aligning the guidelines for COVID19 and the theme, the States may plan for observation of NDD 2020 by carrying out the following indicative activities:

- 1. Messages on Social media on the occasion of NDD
- 2. Interview on Doordarshan/ All India Radio on the occasion of NDD

3. Short messages on All India Radio (AIR)/ FM/Community Radio or other local channels

4. SMS messages on Dengue on the occasion of NDD for better outreach to each & every individual as per the Theme

5. Sensitizing Community by assessing COVID-19 situation in the area that stored water need to be covered properly to prevent *Aedes* mosquito breeding and to adopt personal protection measures in order to protect themselves from mosquito bites

6. Any other innovative way suitable for the area concerned.

However, activities are to be carried out in an integrated manner with COVID-19, as per the prevailing category of Zones or Containment area on the day of activity. Practices of social distancing and personal protection need to be followed during all programmatic activities.
