1. At the outset, the Chairperson welcomed all the members present at the meeting.

- 2. The convener, Hospicio Hospital, Margao read the minutes of the meeting held on 30/12/2020 and reviewed Annexure 2.1 regarding empanelled providers (Minilap Tubectomies, Laparoscopic Tubectomies & Vasectomies), Annexure 2.2 regarding Line Listing of Sterilization trained/empanelled providers, DQAC Functionality Status, Annexure 2.3, Monitoring Plan and Findings of Client Exit Interview for the last quarter (Oct to Dec 2020). The monthly sterilization performed reports for the last quarter received from PHCs/CHCs and other private hospitals/clinics were reviewed. It is informed that total 43 hospitals have sent the reports however 3 hospitals, i.e. Rebello Hospital, Margao Vishwa Sanjivani Health Centre, Baina Vasco & Royal Hospital Margao have not sent their reports. It is informed that sometimes some hospitals are not complying with even NIL report.
- 3. The Convener stated that, this office has to send letter with excel sheet for all the Hospitals to send their compile reports of Sterilization and MTP surgeries performed.
- 4. Informed that Facility Audit Inspections of Hospitals from Salcete, Curchorem, Vasco & Ponda Taluka of South Goa District should be carried out and this quarter (Jan to March 2021) Hospitals from Mormugao Taluka are due for Facility Audit Inspections. The Member Dr. Ira Almeida, stated that the decision of the then Collector to continue the inspections of all the hospitals even if the hospitals are not empanelled.. The Collector stated that Health Officers should carry out the inspections in their concerned jurisdiction for the year 2021.
- The Collector inquired whether internal and external inspections of the hospital are being carrying out. The convener informed that under LAQSHYA and NQAS the inspections have been conducted.

It is informed that no failure of sterilization and no death/complication reported for this quarter.
