- Welcome by the Chairperson-Dr. Rajesh Dhume, Sr. Psychiatrist on behalf of Convener/Medical Suptd/Dy. Director welcomed the members and initiated the proceedings.

- 4. **Discussion of failure of sterilization if any** Dr. Mahendra Ghanekar, Sr.Gynaecologist informed that no death and no failure of sterilization have been reported in last 3 months. It was also informed that there were no vasectomies performed in last 3 months.
- 5. Dr. Mahendra Ghanekar, Sr. Gynecologist/Member informed that two case of sterilization failure was reported in the month of April 2024 and May 2024 and the same was presented and discussed in the meeting.

- ii. In respect of Smt. Yasmeen Chittevale, R/o Caranzalem Tiswadi, North Goa.
- 6. The 2nd case of failure of sterilization where ligation was conducted in Goa Medical College and Hospital Bambolim, the documents namely Adhaar card of husband and election card of wife is from Karnataka.
 The present protocol was to give compensation when sterilization protocol was conducted in the state.

Query was raised by the Chairperson of the DQAC that whether 50% of the compensation is to be given from the state funds or the case to be forwarded to the concerned authority of the Claimant.

- Necessary documents are to be forwarded to Collector North in order to approve the compensation to the patient.
