QUOTATION NOTICE

- Sealed quotations are hereby invited by Director of Health Services, DHS, Panaji-Goa for supply of Direct Ophthalmoscope and Indirect Ophthalmoscope to various health centres across the state as mentioned in the specification in table A.
- The quotations should reach Room F34, First Floor, Directorate of Health Services, Campal, Panaji-Goa on or before 29/01/2025, latest by 5:00 pm.
- Envelope should be superscripted as "Quotation for Direct Ophthalmoscope and Indirect Ophthalmoscope under NPCBVI".
- Quotations should be submitted inclusive of all taxes, duties charges etc as per Table 'B'.
- The tenderer should deliver and install the equipment within a period of 10 days from the receipt of the firm order, give the demonstration, and train the staff of the department free of cost, failing which the order will be treated as cancelled without further notice.
- The supplier may insure the equipment at his own cost to safeguard the delivery of the equipment dispatched by him to the consignee as the department will not be responsible for the damage or pilferage of goods during transit.
- Warranty period of the supplied product shall be <u>one year</u> from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods at delivery location.
- The rate quoted should be valid for a period of <u>one year</u> from the date of acceptance of the quotation.
- The bill should be furnished in quadruplicate with the revenue stamp. The stock should be supplied directly at the destination mentioned in the order to the respective health centres.
- Quotation should have GSTIN No. allotted to the supplier by The State Tax Authorities, without which quotations will not be considered valid.
- No modification in the rates will be accepted/entertained, except in case of changes made and agreed by the Department.
- Conditional offers are liable to be rejected.
- The quotations received after the prescribed date and time or without fulfillment of the prescribed condition will be summarily rejected.
- The Department will not make any advance payment. However, bills could be paid promptly on receipt of service reports.
- Income tax etc will be deducted at source (TDS) from the bills as required under I.T. Act.
- Once the quotation is finalized, successful bidder will require to submit Performance Security in the form of Demand Draft @ 3% of the supply order value placed. The deposit should be in the form of Demand Draft of State Bank of India or any scheduled bank in the favour of

"STATE HEALTH SOCIETY GOA", payable at Panaji-Goa. The Performance Security to be valid for the duration of the one year from the date of supply.
