

Following points were discussed in the meeting:-

5. **Presentation of quarterly reports of Sterilization-**Dr. Atul Gaunekar Sr. Gynecologist briefed regarding the quarterly sterilization report of OBG department. Also informed that no death have been reported in the last 3 months (July to September 2025).
6. **Discussion of failure of sterilization if any-** Dr. Atul Gaunekar Sr. Gynecologist/Member informed that three case of sterilization failure was reported in the last 3 months, the details are as follow:-
 - in respect of Smt. Purnima Sagar Jamuni, R/o Thivim, North Goa.
 - in respect of Smt. Seeta Devi, R/o Calapur, Tiswadi Panaji Goa
 - in respect of Smt. Sakkubi S. Pujar, R/o St. Cruz Band, Taleigao, Panaji Goa

The above all 3 cases were presented and discussed in the meeting. Necessary documents were certified by the Chairman and Committee members in order to give compensation to the patient.

8. **Any other subject with permission of the chair-** No other issue was discussed in the meeting.
